### **POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 30 JUNE 2020**

References are made to the circular (the “**Circular**”) and notice (the “**Notice**”) of the annual general meeting (the “**AGM**”) of Geotech Holdings Ltd. (the “**Company**”) both dated 27 April 2020. Unless otherwise defined, capitalised terms used herein shall have the same meanings as those defined in the Circular and the Notice.

#### **RESULTS OF THE AGM**

The Board is pleased to announce that at the AGM of the Company held on 30 June 2020, all proposed resolutions (the “**Resolutions**”) as set out in the Notice were duly passed by the Shareholders by way of poll.

As at the date of the AGM, there were 1,680,000,000 shares, being the total number of Shares entitling the holders to attend and vote on the Resolutions at the AGM. There were no Shares entitling the Shareholders to attend and abstain from voting in favour of the Resolutions at the AGM pursuant to Rule 13.40 of the Listing Rules. No Shareholder was required under the Listing Rules to abstain from voting on the Resolutions at the AGM. No parties had indicated in the Circular of their intention to vote against or to abstain from voting on any of the Resolutions at the AGM.

The Company’s branch share registrar and transfer office in Hong Kong, Boardroom Share Registrars (HK) Limited, was appointed to act as the scrutineer for the vote-taking at the AGM.
